## Curfew times

I agree to the curfew times stipulated below

Onsite Residence:

Students aged under 14 cannot leave the residence without a designated staff member or group leader. There will be opportunities throughout the day and evening to go to the shops with a Burlington School staff member.

Students aged 14-15 are allowed to leave the residence but must be back by 18:00

Students aged 16-17 are allowed to leave the residence but must be back by 22:00

The Live-In Residence Supervisor will check they are back in the Onsite Residence by 22:00 every evening. If they have not returned to the residence on time, they will be contacted via our emergency phone number. If no contact can be made, the parent/guardian will be contacted.

Homestay:

Students aged 14-15 are allowed to leave the homestay but must be back by 18:00

Students aged 16-17 are allowed to leave the homestay but must be back by 22:00

If they need to take public transport to get back to their homestay, please ensure they leave plenty of time for travelling to avoid being late.

If they arrive home late, the School will be informed and action will be taken.

# Social Programme

The School's morning social programme is compulsory on the Young Learner Programme.

You will be supervised on prearranged morning activities Monday to Friday and also a full day excursion on Saturday (extra fee for Saturday excursions applied to Day Programme Students).
